In cases of offensive interference by a baserunner, other runners normally return to the last bases touched at the time of the interference. Exceptions include:

Batter-runner is called out for interference before he reached first base, on first play of the bat. Base occupied at time of pitch.
(2.00-Off. Int.)

Baserunner deliberately interferes with a batted ball or fielder with obvious intent of breaking up a double play. Base occupied at time of pitch.
(7.09g)

Rundown on a runner between home and third, where back runner is at third when runner is called out for interference--back runner returns to second.
(7.08b-fp)

Batter-runner deliberately interferes with a batted ball or fielder with obvious intent of breaking up a double play. Base occupied at time of pitch.
(7.09h)

Baserunner is called out for being hit by fair batted ball in fair territory--other runners return unless forced to advance.
(5.09f & 7.08f)

Baserunner is called out for illegally crashing into the pivot man during a double play attempt. Base occupied at time of pitch.
(6.05m)
